

# 2022 Run Domestic Violence Out of Town Chicago Half Marathon Team Self Registered Runner Release Form & Contribution Agreement

## Fundraising Commitment

I agree to collect a minimum of \$600 by 5 PM, November 1, 2022 for my part of the 2022 Run Domestic Violence Out of Town Chicago Half Marathon Team.

To guarantee my fundraising commitment, I will provide Run DV with a credit card valid through November 2022 and all pertinent credit card information as part of my 2022 Run DV team registration process. I agree that Run DV may charge my credit card for the difference between what I fundraise for Run DV by 5 PM, November 1, 2022, and \$600.

I understand that all funds raised will support Run DV Out of Town.

I agree that I will not begin the race prior to the official start time; I will not compete in a manner which, in the judgment of the race officials, interferes with race operations or other participants, and I will not reproduce or transfer my official bib number.

I will return this signed agreement in order to be recognized as a team member of Team Run DV within the HOKA One One Chicago Half Marathon.

## Release Form and Contribution Agreement

In consideration of my accepting this entry, I hereby for myself, my heirs, executors and administrators, waive and release any and all rights for claims and damages I may have against Run DV, its employees, volunteers, officers and sponsors for any and all injuries suffered or sustained by me in said event, in the training and planning sessions for said event, or travel to or from any of the preceding. I further attest and certify that I am physically fit and have sufficiently trained for competition in this event, and a licensed medical doctor has verified my physical condition.

I hereby assume any and all risks related to such event. I also grant permission for use of my name, photograph, or voice in broadcast, telecast, print or any other account of this event and agree to waive any compensation for such use. I agree to provide a current or recent photograph of myself upon request from Run DV.

I declare that I have exercised my own judgment in accepting this agreement, and I further declare that the decision to accept this agreement is voluntary, that I am competent to enter said agreement, and that I was not forced or coerced by anyone, including Run DV, to enter into this agreement.

In the event of an illness, injury, or medical emergency arising during the event or in the training and planning sessions for said event, I hereby authorize and give my consent to Run DV to secure from any accredited hospital, clinic, and/or physician any treatment deemed necessary for my immediate care. I agree that I will be fully responsible for payment of any and all medical services and treatment rendered to me including, but not limited to, medical transport, medications, treatment, and hospitalization.
